WEDDING CONTRACT, TERMS AND CONDITIONS

It is mutually agreed that the following terms of agreement form the integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by both **Graham Slocombe Photography** and the client, in writing.

Booking Deposit:

A deposit of £200.00 is required at the time of booking, together with a signed contract. Dates are reserved from this date. Please make cheques payable to **Graham Slocombe**. An unconditional refund policy exists for a period of 21 days from receipt of this contract and payment.

Balance Payment:

A balance payment is to be made no later than 30 days prior to the wedding ceremony. Payment for additional album photographs, prints and frames is made after the wedding at the time of ordering.

Fees:

All reprints will be treated as an extension of this contract and no responsibility for errors will be accepted unless orders are given in writing. Prices for wedding reprints or pre-wedding shoot prints are at current prices.

Creative License:

Graham Slocombe Photography is granted creative and artistic license in relation to the choice of locations and poses and locations used. Photographic style and the number of photographs taken shall be deemed the decision of **Graham Slocombe Photography**. This can be influenced by changes of weather and willingness of subjects. We endeavour to honour requested photographs but do not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement.

Coverage:

Graham Slocombe Photography can not be held responsible for the lack of coverage caused by late arrival of bride, groom or guests.

Colour Match:

It is not possible to guarantee exact colour matching between proofs and reprints unless the proofs are returned during reprinting.

There are some materials that digital media finds difficult to accurately render, and no guarantee can be made that all the subtleties of colour will be reproduced.

Model Release:

The client gives their consent to the use of resulting photography for samples, advertising the work of the photographer and professional exhibitions/ competitions.

Copyright:

The 1998 Copyright, Designs and Patents Act assigns copyright to **Graham Slocombe Photography**. You may not copy the photographs taken under this contract, or allow copies to be made photographically, electronically or by any other means except without prior and written consent from **Graham Slocombe Photography**.

Force Majeure:

The due performance of this contract is subject to alteration and cancellation by Graham Slocombe Photography owing to any cause beyond their control.

Limitations of Liability:

In the unlikely event of partial or total photographic failure or cancellation of this contract by Graham Slocombe Photography liability shall be limited to a full refund of all monies paid. Your statutory rights are not affected.

Cancellation:

If **Graham Slocombe Photography** has to cancel this contract for reasons beyond his control, (death, injury, sickness etc.) his liability shall be limited to a full refund of all monies paid. The client may cancel this contract at any time. After a period of 14 days from the date of signing the contract, as compensation for the loss of income for **Graham Slocombe Photography**, the following charges apply as a percentage of the total fee due.

Charges for cancellation after 8 weeks shall be as follows:

55-42 days 25% 41-28 days 50% 27-15 days 75% 14 days or less 100%

Should the cancelled wedding turn out to be a postponement, then, subject to availability, all money paid may be applied to the new wedding. In this case, the total fees chargeable shall be the fee which applies at that time. In the event of **Graham Slocombe Photography** taking another wedding booking for your cancelled or postponed date a full unconditional refund of your deposit and monies paid shall be made.
